Election Notice

Dear Members,

26th Oct, 2024

The term of the current executive council will be completed on 31st March 2025 and a new EC shall take over from 1st April 2025.

As per the constitution vide rules and regulation — part II (article 7.4) election shall be held for the following posts:-

| POST | NUMBER OF VACANCY | ELIGIBILITY |
|-------------------|-------------------|---|
| President | One | Valid Life Membership atleast for 10 (ten) years. Completion of atleast 2 (two) Full Terms of which one as Office Bearers in Elected position in the Council. |
| Vice-president | One | Valid Life Membership atleast for 10 (ten) years. Completion of atleast 1 (one) Full Terms in Elected position in the Council. |
| Hony. Secretary | One | Valid Life Membership atleast for 8 (eight) years. Completion of atleast 1 (one) Full Terms in Elected position in the Council. |
| Joint Secretary | One | Valid Life Membership atleast for 5 (five) years. Completion of atleast 1 (one) Full Terms in Elected position in the Council. |
| Treasurer | One | Valid Life Membership atleast for 5 (five) years. Completion of atleast 1 (one) Full Terms in Elected position in the Council. |
| Member Of Council | Eight | Valid Life Membership atleast for 3 (three) years. |

Important:-

- The term of the fresh EC shall be for 2 (two) years (from 01/4/2025 to 31/03/2027).
- Only Life Members are eligible to vote and hold office.
- Associate members, Overseas Members, and PGT Members are not eligible to vote or serve in the Executive Council.
- 1 (one) valid Member can contest for 1 (one) post only otherwise his/her candidature for all post will stand automatically cancelled.
- No Member can hold office for more than 2 (two) consecutive terms in the same post.
- Canvassing in any form or in favour of the candidate shall not be permitted.
- Nomination papers **received after 25th November 2024** by post or E mail will be rejected straight away.
- Incomplete nomination paper will also be rejected.

Members willing to contest for **the post in the EC (2025 - 2027) are required to:-**

- (i) Send their nomination papers (format enclosed/also can be downloaded from www.iapmr.in) duly proposed and seconded by valid Life Members of the Association by post to Election sub-committee office or by E mail with scanned copy of the nomination paper by 25th November 2024
- (i) Send their brief Bio-data in not more than 100 words and a recent passport size photograph which will be circulated to all valid Life Members in the event of an election, to Election sub-committee office or by scanned copy by e-mail of the both biodata and Photo
- (ii) Election sub-committee / Tribunal / GB will sort out any dispute.

The Election shall take place according to the following schedule laid down in the constitution: -

If the nominations are more and requires an election – the election subcommittee will take a decision accordingly and subsequent process will be intimated
